

Santa goes Virtual

We are sad to report that the normal Santa comes to Irby event, together with the Christmas lights switch on, has had to be cancelled this year due to the Covid 19 epidemic and the restrictions on households mixing.

The good news is, there will be a "virtual lights switch on" – live, on line, on Facebook.

This exciting innovation is being designed and managed by Joe Hollywood who lives in Irby and who is CEO of Ocular Media Limited. As well as being the switch-on DJ and MC for the past three years, Joe is a media and social networking whizz.

The virtual switch on will take place on the planned Santa Comes to Irby switch on night (Friday 27th November). Irby residents will be able to tune in to Facebook to see some pre-switch on tasters such as Santa in the Shippons answering children's questions.

The switching on of the Christmas lights will follow the countdown at 6.00 pm, when Santa pushes the plunger.

The collaborative group, of which ITPAS is a part, wish to discourage people from gathering in the village. At the time of going to print, this is not only against the law but residents would run the risk of catching or spreading the Covid 19 virus.

There will be drone footage of the lights, again on Facebook, so that everyone may enjoy them from the comfort of their own homes.

Keen observers will spot that this year, there are some new fairy lights in the seven trees on the central reservation between McColl's and Aroma. ITPAS successfully bid for a grant from Wirral Borough Council's "Wirral Together" fund.

Footnote: ITPAS has long been a representative body within the collaborative group which organises this popular annual event. The group comprises representatives from The Shippons, The Irby Club, Irby Village Hall, ITPAS and Irby Evangelical Church, but there are many other supporters and contributors who also help out in one way or another.

Whaley Lane/Pensby Road Flower Beds

The existing flowerbeds on the corner of Whaley Lane and Pensby Road were looking very unkempt and the site had become infested with weeds.

ITPAS applied for funding through the Councils 'Wirral Together' initiative and we were pleased to receive a contribution of £340.70 to improve the site. We used the monies to purchase shrubs, bark and weed suppressant membrane and set about tackling the existing overgrown plants, which resulted in four-ton rubble bags full of weeds and clippings. We have now planted additional shrubs to add seasonal colour and are pleased with the results and with the many positive comments we received from passers by. The scheme compliments the daffodil planting we undertook on the adjacent grass verge a couple of years back.





Council grant funding initiatives are welcomed by ITPAS as they allow us the opportunity to enhance our environment for the benefit of residents and visitors alike. When funding opportunities arise it is vitally important that we seize them on behalf of the community. We are indebted to the Ward Councillors for supporting our schemes through 'Wirral Together' funding without which none of the projects would be possible. Particular thanks go to Helen Gallagher, Constituency Engagement Officer for Wirral West who has been incredibly supportive of our work, has alerted us to, and guided us through the process each time a grant has become available. Her efficiency, gentle cajoling and enthusiasm have been an asset to the Society in achieving our funding goals.

Thurstaston Roundabout Regeneration Phase 2





Thurstaston Roundabout is situated at the gateway to Wirral's 'Jewel in the Crown' – The Wirral Country Park, a significant tourist attraction in the Borough and within the Thurstaston Conservation Area. Constructed in 2005 in response to safety concerns over the existing crossroads, a great deal of thought went into the design to ensure it enhanced its special location. Over time, the original planting scheme had become overgrown and unkempt and prompted ITPAS to apply for funding to weed, renovate and add additional planting. Phase 1 of the grant resulted in the pruning back of existing overgrown shrubs and the addition of new plants. The project proved to be a big undertaking and the looming lockdown due to Corona virus meant we managed to complete the work with just a day to spare. Over the following months we have made regular trips to water the plants but to a great extent they have had to be left to fend for themselves. Recently we began work once more and were relieved to see that virtually all the plants have come through the Summer unscathed and are flourishing. We have now secured additional funding in the sum of £952.50 through the 'Wirral Together' initiative to begin Phase 2 that entails enlarging the flowerbeds, weeding and applying mulch. Hopefully by next Spring the results of the work will begin to pay off.

Planning Update - Local Applications

Despite Covid restrictions, ITPAS has kept its watch on all Planning Applications in our Area. We have continued dialogue with Case Officers and Department Managers, who have for the most part been working from home. Where thought necessary, we have made comments and lodged Objections both online through the Council's Website and by email. The vast majority of Applications, however, were non-controversial.

After a long working association with the Head of Planning (David Ball, shown Left), he has now moved to be 'Head of Special Projects', part of a major restructuring of the Planning Department, which sees the creation of several new Senior Manager posts. Meanwhile, overseeing the Applications Section as well as the Local Plan production and other Forward Planning matters is Alan Evans (shown Right), who has risen rapidly to become the 'Director of Redevelopment & Place'.



ITPAS has been dealing with Alan Evans over the Wirral Local Plan and took the opportunity during our most recent 'ZOOM' meeting with the Council Team to raise four Application Decisions all involving Green Belt and other Planning matters of serious concern. We followed this up with full written details but received a disappointing response, which we don't believe stems from his personal review. The ITPAS Committee will discuss each issue in the Response during their imminent 'ZOOM Meeting', and seek further expert advice.

Brief details of concerning Applications below; then current status of a few others.

APP/16/01079 - Housing in Green Belt, Heatherlands, Thurstaston Road/School Lane

The main issue: the development does not follow the Approved Plans, particularly in respect of measures agreed to make the Proposal acceptable within Green Belt, namely a wide, open landscaped area between the Bungalow (facing Thurstaston Road) and School Lane, to be bordered with a hawthorn hedge and trees.

The Application made great play of this feature's significance to maintaining the openness of this part of School Lane and Green Belt. The area was to be planted so as to create a species-rich habitat. (Extract:)

"Overall, an enhanced flora and fauna habitat will be created by an appropriate, comprehensive landscaping scheme based on the consultation undertaken to date with the local authority Tree Preservation Officer, The Hedgerow Trust, and the findings and recommendations of the commissioned Habitat survey."

The 2 insets show the approved Site Plan (top) and today's reality (below), a high fence line, not on published drawings, a total lack of 'openness', no visual relief and no planting, creating a 'tunnel-like', inappropriate feel. It appears that the garden to the Bungalow has just been extended across this zone. Gardens, with their heavy use, soil compaction, toxic chemicals and domestic paraphernalia don't provide conditions for a 'species-rich habitat'. What do YOU think?

We were prepared to accept the altered spacing of Buildings, even the 'retrospective' Application changing elevations (undetermined for 16 months until built and we alerted WBC), but this seems to be another example of *commitments made in Applications but not delivered*, and a Council admitting they do **NOT** routinely check what is actually built. We think they should and Building Control have this duty.



APP/20/00576 - New House in Green Belt at Wellington Barn, Mill Hill Road - APPROVED!!

After years of the Council, Local Councillors, ITPAS, Wirral Society, other Groups and members of the public all agreed that a new house in undeveloped space on this Site was not appropriate and would affect the 'openness' of Green Belt, a fresh Application with a different Case Officer, despite Objections, has been approved under delegated powers. ITPAS and our advisers believe WBC has made a wrong Decision, one which sets an awful precedent in that (it is advised) they have quoted incorrectly, "Land in equestrian use is considered 'previously developed' and capable of redevelopment in principle for housing under the terms of the NPPF." This is a real concern right across Wirral: what's to stop Green Belt owners putting horses on a field for a year or two to obtain 'Previously Developed' status, seeking Planning Approval and citing this precedent?

RESX/20/00187 – The Old Rectory, Thurstaston – Large Forward Extension does NOT require Planning Consent!! (Objected to by ITPAS, as were large extensions in 2019)

Despite Refusals for extensions to this prominent house (already beyond that permitted in Green Belt), including those sought last year, described by WBC as "inappropriate, disproportionate, out-of-character, harmful" on a Site of protected 'Local Woodland' and sensitive biodiversity, the Council has now decided a large extension towards Telegraph Road may proceed **WITHOUT** Planning Consent.

ITPAS, has shown this error stems from the Council accepting that the elevation facing the River, the Welsh Hills and the Telegraph Road entrance is the 'Rear Elevation' when it is clearly what is termed the 'Principal Elevation' which cannot be extended without Planning Consent. Despite our Planning Consultant writing to the Council, concluding with concern that such a development could be "unlawful", and despite our providing clear evidence to the Head of Department and Alan Evans, the Council refuses to admit its mistake. Therefore, reluctantly we must consider further action.

ITPAS's main concerns are an apparent fault in judgement and a bad precedent. Whilst we are not opposed to extensions *per se*, we believe that all development within Green Belt (where not 'Permitted Development') should be subject to a Full Planning Application, and judged on merit.

APP/20/00414 - 10 New Dwellings in Green Belt, Top House Farm, Thingwall Road East

This Application, submitted in March 2020, follows earlier refusal for four new dwellings on the Site. We believe that the planning principles of this Site have been established through prior Refusals and the Council should not be taking so long and seemingly negotiating with the Applicant. The Proposals are completely 'inappropriate' within Green Belt and on this Site particularly.

As can be seen from the photographs below, the Site was originally a single Farmhouse and barns on a tidy, green site adjacent to Arrowe Park. Subsequently, permissions were given to split the Residence into two, which later gained approval for extensions. Meanwhile, the old metal barn fell down and that part of the Site was used for storage and dumping, and left unmanaged. ITPAS (as well as the Wirral Society, Wirral Wildlife and others) argue that poorly managed Green Belt should not be grounds for accepting development but instead should prompt 'Enforcement' to restore the Land.

ITPAS will seek further advice and challenge the Council over these defective outcomes.

We give details below of the current status of a few other 'historic' Applications:

APP/20/00183 - Greenheys Nursery, Thurstaston Rd, Irby - Consent renewed for replacement house.

No further applications for the remainder of the Green Belt site, although some tree-felling has been noted.

APP/20/00763 – South Lodge, Station Road, Thurstaston – Replacement of 20th Century Extension to historic Lodge, New Extension and Remodelling to form substantial Dwelling - APPROVED.

Well-designed, remodelled dwelling, preserving and enhancing the historic Lodge (main gateway to 'Dawpool House', home for a few years to Thomas Henry Ismay ['White Star Line']) by removal of lower quality additions and an unsightly garage, and a sensitive new extension maintaining the significance of the Lodge. The whole is fitting to its location in Green Belt and the Conservation Area.

APP/20/01065 - 9&10 Copse Grove, Irby: 2 Houses & Garages on Greenspace - Undecided 3 months.

ITPAS lodged Objection to development of this 'greenspace', set aside for enjoyment of Residents but poorly maintained. Similar proposal had been Refused. Site includes part of Copse stretching into adjacent Green Belt containing a pond – risk of harm to ecology and biodiversity. Exaggerated claims of benefits; clearly inappropriate; continuing grounds for Refusal - taking too long to decide.

Planning Update - the Wirral Local Plan:

Covid-19 has disrupted Local Plan Examination nationally. To avoid even higher penalties from its 20-year delay, the Council agreed to just one further year, and must complete the Plan under the existing Planning System but, upon 'Plan Adoption', has to embark on a 30-month (max) Plan Review under the new Planning System (if in place by then). The latest Timetable is:

February 2021 'Regulation 19' Document to be Published (full Draft Local Plan)

March/April 2021 6-week Public Consultation on Draft Plan (incl. all Evidence Base Docs)

June 2021 Final revisions completed and Local Plan Submitted for Examination

Autumn 2021 Local Plan Examination and Hearings

Any 'Main Modifications' Consultation actioned and Local Plan Adopted Spring/Summer 2022

ITPAS has worked throughout the Pandemic with 'Wirral Green Space Alliance' (WGSA) by email and online meetings with colleagues and the Council, keeping pressure on production of a Local Plan that would deliver the type of 'Regeneration' actually needed AND protect Green Belt. Further progress has been achieved but the major issue remains WBC's lack of courage to argue for a realistic additional 'Housing Need' of circa 4,000 rather than the absurd 12,000 figure. Latest ONS Data and flexibility make this a simpler task as both Prof Gregg and Graham Stevens have shown in their statistical Papers. It may be the Council hopes the WGSA Case will do the job for them at 'Plan Examination'. But, this is a risky policy which, if unsuccessful, could see the Inspector requiring some Green Belt Release (yes, the Council's admitted previous policy!!).

On the positive side, WBC state they have identified more than enough 'brownfield' and other 'Previously Developed Land' (PDL) to meet their higher figure, although this is dependent on securing funding of around £200 million (just £6m to date!!) from 'Homes England' and other sources, and on the Developers' call for over 12,000 additional homes and Green Belt Release failing. Other progress with WGSA suggested 'Action List' includes higher early delivery by Peel at 'Wirral Waters'; identification and inclusion of redundant sites and buildings which could have their 'Use' changed to 'Housing'; reduction of new and conversion of surplus Retail space; and a lower requirement for the Council's own operation post-Covid. They have not yet agreed to increase the 'Empty Homes back into Use' figure from just 50% of the existing consistent delivery. Why?

ITPAS has informed the Council that we consider it is bordering on obscene that:

- the Local Plan, despite their claiming it is centred on 'Regeneration', will NOT include ANY Upgrading or Replacement of the thousands of poor quality ('substandard') homes recorded in its official Reports - sends out a totally wrong message, a lack of care for those most in need
- further, we consider that this fact, confirmed by the Council Team, is likely to be very badly received by those still suffering life-limiting conditions – poor quality ('substandard') housing contributes to the ten-year disparity in life-expectancy between west and east Wirral; and
- the Council is not following up on recent clarifications of intentions by Christopher Pincher MP (Housing Minister) who, in a House of Commons Debate [Planning & House Building] said, "We will consider such factors as stock renewal, so we level up those areas of our Country ... that suffer from poor-quality housing and infrastructure." Why does this not apply to Wirral, you may ask?

At Reg 19, the Draft Plan and all Evidence Base Documents (underpinning the Plan) will be consulted upon but with limited scope. ITPAS has argued that WBC has made and acted upon decisions before they have produced the Evidence and Policies or fully appraised the thousands of Consultation Responses (DOR-2018 and I&O-2020 particularly). However, this is not expected to be ruled unlawful or vitiate the Process.

Since the 'Issues & Options' (Reg 18) Consultation back in April, ITPAS and WGSA have worked through and Responded to five such Evidence Base Documents' Consultations (there are more to come but when?) denoted [●] and the two major Consultations on possible changes to the national Planning System [■]:

- 'Agricultural Economy and Land Study Addendum' (ITPAS response 17th July 2020)
- 'Wirral Landscape Sensitivity Assessment Addendum' (Ditto)
- 'Wirral Local Landscape Designations Review 2020' (Ditto)
- Liverpool University Report: 'Exploring the computation of housing need in Wirral' (July '20)
- 'Green & Blue Infrastructure Strategy' Workshop + Survey (ITPAS took part in both in June '20) [exercise to produce an Evidence Base Document; WGSA chasing completion and Consultation]
- 'Changes to the current planning system' Consultation (October '20)
- 'Planning for the Future' White Paper Consultation (October '20)

ITPAS & WGSA are working hard but finding it difficult to identify sufficient common ground with the Council.



Thurstaston

Thurstaston means "village of a man called Thorsteinn/Þorsteinn", from the Old Norse personal name Thorsteinn/Þorsteinn and Old English tún "farm, village". [4] A record of the name as Torstestiune in 1048 proves this origin.

The village was mentioned in the Domesday Book of 1086 as Turstanetone. [5] Historically and popularly, the name was wrongly thought to refer to "Thor's Stone", a sandstone outcrop on Thurstaston Common. [6]

Pensby

The name Pensby comes from Old Norse, meaning a village or settlement at a hill called "Penn". [3] The "by "suffix, included in neighbouring place names such as Frankby, Greasby, and Irby, is Viking in origin.

Pensby was originally a village in Woodchurch Parish, Wirral Hundred. The population was 22 in 1801, 48 in 1901 and 2,996 in 1951.[4] Lower Pensby was previously known as Newtown. This was due to the building of new houses around the turn of the twentieth century at the crossroads of Pensby Road and Gills Lane.[5]

On 1 April 1974, local government reorganisation in England and Wales resulted in most of Wirral, including Pensby, transfer from the county of Cheshire to Merseyside

The name Irby is believed to be of Viking origin, meaning; "the farmstead of the Irishmen".[4] Other nearby towns and villages with the Viking "by" suffix in their name include Frankby, Greasby and Pensby.

The village was formerly a township in Woodchurch Parish, Wirral Hundred. On 1 April 1974, local government reorganisation in England and Wales resulted in most of Wirral, including Irby, transfer from the county of Cheshire to Merseyside.

If you did not receive this Newsletter by email or post to your home it may be because we do not have your current address. Please contact me if you have any doubts about the completeness of our records.


